## OPINION AND FINDINGS

On January 13, 2006, Qwest Corporation filed an application seeking to accelerate NUSF support granted by the Commission in its October 6, 2004 Order. Notice of the application was published in the Daily Record on January 25, 2006. On February 21, 2006, the Rural Independent Companies filed a Petition for Formal Intervention. A Response to the Petition was filed by Qwest on March 7, 2006. A Reply to the Response was filed by the Rural Independent Companies on March 13, 2006.

On April 25, 2006, a planning conference was held in the above-captioned application. At the planning conference, the Hearing Officer granted the RIC Petition for Intervention. The Hearing Officer also ruled that the confidential information Qwest filed in the previous NUSF-7.07 application would not be released to the RIC as the information is part of a proceeding that has been ruled upon with a final order.
