By Application filed February 1, 2012, N.E. Colorado Cellular, Inc. d/b/a Viaero Wireless (Viaero) seeks Nebraska Broadband Pilot (NEBP) Program support. Notice of the Application appeared in the <u>Daily Record</u>, Omaha, Nebraska on February 7, 2012.

On April 3, 2012, the Commission held a planning conference to establish a case progression schedule and a hearing date. With the consent of the parties in this matter, the following procedural schedule should be, and it is hereby, adopted.

May 7, 2012	Pre-filed Direct Testimony is due. If presenting a witness at the hearing, pre-filed testimony must be filed with the Commission and served on any other parties to the proceeding.
May 21, 2012	Pre-filed Reply Testimony is due. Pre-filed testimony must be filed with the Commission and served on any other parties to the proceeding.

The hearing on the application will be held on May 30, 2012, in the Commission Hearing Room, 300 The Atrium Building, 1200 N Street, Lincoln, Nebraska 68508 commencing at 1:30 p.m. central time. The Commission also reserves May 31, 2012 as

necessary to complete the hearing. If May 31, 2012 is needed, the hearing will commence at 10:00 a.m. in the Commission Hearing Room. The hearing will be consolidated with NUSF-77.01, NUSF-77.02, NUSF-77.03, NUSF-77.04, NUSF 77.05 and NUSF-77.07. The hearing will be held in the traditional format. Witnesses will be sworn-in and cross-examination by intervening parties will be permitted. An outside court reporter will be hired to transcribe this proceeding and applicant will be required to pay an equal share of the cost of the court reporter services with the other six applicants.

Counsel for the parties are requested to provide the Commission staff with an estimate of time needed for cross-examination at least two (2) days prior to the hearing.

The Commission will determine post-hearing filing deadlines at the close of the hearing.
