BY THE COMMISSION:

On September 8, 2010, the Nebraska Public Service Commission (Commission), on its own motion, opened the above-captioned proceeding to amend Title 291, Chapter 5, Telecommunications Rules and Regulations, to adopt rules regarding filing of agreements containing terms for provision of access services at rates or charges different from the rates and charges for such services contained in a carrier's tariff on file with the Commission.

The Commission released a first set of proposed rules and regulations and requested comments from interested parties. Based upon the comments received, revisions to the proposed rules were made and a second set of proposed rules and regulations were released for comment and a hearing scheduled.

On February 25, 2011, two district court opinions were issued in two appeals dealing with issues surrounding access rate regulation by the Commission. To allow time to determine the impact of the court's order on the proposed rules in the above-captioned docket, the Hearing Officer postponed the comment period and continued the hearing.

Due to the district court orders concerning access regulation, the Commission finds that broader more comprehensive rules regarding access regulation would be more efficient, and a more coherent and consistent discussion of access rate policy preferable. New rules and regulations, including rules similar to those drafted in the above-captioned rulemaking, shall be drafted outlining more comprehensive Commission access rate policies and procedures.

The Commission finds that this docket should be closed. Once a new proposed rules and regulations have been drafted, the Commission will initiate a new rule and regulation docket.
