OPINIONS AND FINDINGS

By application filed February 2, 1990, Lannie L. Roblee, dba Midwest Prisoner Transportation Service, Curtis, Nebraska, hereinafter referred to as applicant, seeks a certificate of public convenience and necessity to operate as a common carrier of prisoners by motor vehicle as follows:

AUTHORITY SOUGHT

Transportation of prisoners between points in Nebraska over irregular routes.

Notice of the application was published in the Daily Record, Omaha, Nebraska on February 5, 1990 pursuant to the rules of the Commission.

Since no protests were filed, Application No. B-1288 was processed pursuant to Rule 018.03 of the Rules and Regulations of the Nebraska Public Service Commission.

After due consideration of the evidence and being fully advised in the premises, the Commission is of the opinion and finds:

1. Applicant is fit, willing, and able properly to perform the proposed service and to conform to the provisions of Section 75-301 to Section 75-322.04, R.R.S. 1943, as amended, and the requirements, rules and regulations of the Commission thereunder.
2. That the proposed intrastate service is or will be required by the present or future public convenience and necessity to the following extent.

3. That the application should be granted.

O R D E R

IT IS THEREFORE, ORDERED, by the Nebraska Public Service Commission that Application No. B-1288 be, and it is hereby, granted; and that upon compliance with the terms and conditions set forth in this order, a certificate of public convenience and necessity shall be issued to Lannie L. Roblee, dba Midwest Prisoner Transportation Service, Curtis, Nebraska in Application No. B-1288 authorizing the operations set forth in Paragraph No. 2 of the foregoing findings.

IT IS FURTHER ORDERED that applicant shall not be issued the certificate of public convenience and necessity authorized by the Commission unless and until applicant has fully complied, within a reasonable time from the effective date of this Order, with Sections 75-305 (Fees), 75-307 (Insurance), and 75-308 (Rates), R.R.S. 1943, as amended, and with the rules and regulations of the Commission; and if upon expiration of such time, applicant has not complied with such terms and conditions, this Order shall, after reasonable notice to applicant, be of no further force and effect.

IT IS FURTHER ORDERED that applicant shall not conduct operations until a certificate of public convenience and necessity is issued.

IT IS FURTHER ORDERED that the certificate of public convenience and necessity authorized shall be subject to the terms, conditions, and limitations which have been, or may hereafter be, prescribed by the Commission.


