Applicant is a certificated common carrier which holds Certificate Number B-1754. The certificate authorizes the transportation of passengers by luxury or stretch limousine in Antelope, Burt, Boone, Cedar, Cuming, Dixon, Dakota, Knox, Madison, Pierce, Stanton, Thurston and Wayne counties and between points within said counties. The transportation of railroad train crews and their baggage is not authorized. The HHS designation is no.

The Applicant is establishing its rates for use in this certificate.

The Applicant represents to the Commission that the proposed rates are based upon anticipated expenses in vehicle maintenance, fuel expenses, insurance premiums, advertising and other overhead charges. The rates as proposed have been developed to be competitive with similar charges for similar services currently being operated.

In applications such as these, the Commission must find that an emergency situation exists. Such a situation exists in this application as the Applicant cannot begin operations under its certificate as granted until the rates are approved.

Upon consideration of the application and being fully advised in the premises, the Commission is of the opinion and finds that the application should be granted on an emergency basis effective June 4, 2010.
