OPININON AND FINDINGS

On May 20, 2010, Chad Schinstock d/b/a Schinny's Wild Ride, West Point, Nebraska, filed an application for authority to establish rates for its use in its operations as follows:

Emergency action is requested.

Applicant is a certificated contract carrier which holds Permit Number B-1751. The certificate authorizes the transportation of passengers and their baggage in special party service between points in Cuming, Dodge, Burt, Thurston, Stanton and Colfax counties. The transportation of railroad train crews and their baggage is not authorized. The HHS designation is no.

The Applicant received authority to operate from the Commission under Permit No. B-1751 on March 30, 2010. The Applicant is establishing its rates for use in this certificate.

The Applicant represents to the Commission that the proposed rates are based upon anticipated operating costs and expenses. The rates are similar and competitive to those being charged by companies providing similar services.
