OPININON AND FINDINGS

On February 18, 2011, Limousine Services, LLC, Lincoln, Nebraska, filed an application for authority to amend its rates for its use in its operations as follows:

<u>Description</u>	<u>Proposed</u>
With a paid booking of three hours	receive one hour free.
With a paid booking of four hours,	receive one hour free.
Emergency action is requested.	

Applicant is a certificated common carrier which holds Certificate Number B-1761. The certificate allows the transportation of passengers by luxury limousine between points within a 250-mile radius of Dakota City over irregular routes. RESTRICTION: 1) The transportation of railroad train crews is not authorized; and 2) The certificate holder shall maintain a listing of its services in the Yellow Pages of the telephone director serving Dakota City.

The Applicant received authority to operate from the Commission under Certificate No. B-1761 on May 11, 2010. The Applicant is amending its rates to add an additional free hour to its bookings of three and four hours, respectively.

The Applicant represents to the Commission that the proposed amended rates are based upon market factors and are an effort to maintain a competitive position with other carriers in the market. The Applicant cites that other carriers in its operating are has similar allowances in its

charges, and needs to be allowed to so to remain competitive with these other companies.

The Commission is aware of the fact that there are other companies in the operating area of the Applicant that do offer a similar rate. The rates as amended are competitive with similar rates charges by other services for these types of vehicles.

In applications such as these, the Commission must find that an emergency situation exists. Such a situation exists in this application as the Applicant would continue to be at a competitive disadvantage that already have a rate structure similar to that proposed by the Applicant.

Upon consideration of the application and being fully advised in the premises, the Commission is of the opinion and finds that the application should be granted on an emergency basis effective March 11, 2011.

ORDER

IT IS, THEREFORE, ORDERED by the Nebraska Public Service Commission that effective March 11, 2011, Limousine Service, LLC, Lincoln Nebraska, be, and it is hereby, authorized to establish rates for the following vehicles its use as follows:




