BY THE HEARING OFFICER:

On April 29, 2014, an application was filed by Servant Cab, LLC d/b/a Yellow Cab Company and Capital Cab Company, Lincoln, Nebraska, seeking authority to adjust its rates and charges by the addition of a charge for any individual, group, business or governmental entity which purchases ten (10) or more trips in a single day (0-5 miles) of \$38.00, and each additional mile or part thereof of \$2.00 per mile. Emergency action was requested.

The Commission entered an order on May 6, 2014, denying the application on an emergency basis and that the application be processed according to Commission rules. The application was published on May 12, 2014. Protests were timely filed by Transport Plus and by Checker Cab Company, dba Checker Cab Company, Happy Cab Company, Yellow Cab Company, DonMark, Inc., d/b/a Cornhusker Cab Company, and Valor Transportation Company d/b/a Safeway Cabs, through their attorney, Andy Pollock.

In order to process the application, the Commission held a planning conference in this matter on September 12, 2014, at 11:00 a.m. via telephone conference. The following persons were present at the conference: Commissioner Frank Landis,; Jack Shultz, attorney for the Applicant; Andy Pollock, attorney for protestant cab companies; Vicki Harding of Transport Plus; and Mark Breiner, Commission staff

As a result of the planning conference, several issues were decided. Therefore, this order serves to memorialize those decisions and to provide a timeline for proceeding in this docket.


O R D E R
