By application filed September 19, 2018, Elite Party Buses, LLC ("Applicant"), Lincoln, seeks to change an existing operation by sale or transfer of stock ownership/membership interest. Applicant proposes to change its existing membership interest as follows: Current membership interest- Tammy Casey (16%), Tyler Wullenwaber (42%), and Chase Mills (42%); Proposed membership interest- Tammy Casey (100%).

Notice of the Application was published in The Daily Record, Omaha, Nebraska, on March 11, 2019, pursuant to the rules of the Commission.

Elite Party Buses, LLC is a Nebraska Limited Liability Company, with its principal place of business in Lincoln, Nebraska. The business headquarters will remain in Lincoln, Nebraska if the transfer of membership interest in Elite Party Buses is approved by the Commission. Elite Party Buses provides transportation of passengers by bus in charter and special party service between all points in Nebraska over irregular routes. The transportation of railroad train crews and their baggage is not authorized, and the HHS Designation is no.

Applicant will continue to provide the same service. Because no protests were filed, Application No. B-1877 was processed pursuant to Commission Rules for modified procedure.

After due consideration of the evidence and being fully advised in the premises, the Commission is of the opinion and finds:

1. Applicant is fit, willing, and able properly to perform the proposed service.

2. The proposed change of control will be consistent with the public interest and will not unduly restrict competition.
3. The certificate issued in Application No. B-1877 is not dormant.
4. An order should be entered in Application No. B-1877 authorizing Elite Party Buses, LLC, Lincoln, to transfer membership interest.

O R D E R

IT IS THEREFORE ORDERED by the Nebraska Public Service Commission that Application No. B-1877 be, and it is hereby, granted; and that Elite Party Buses, LLC, Lincoln, is hereby authorized to change its existing stock ownership/membership interest as follows: Current membership interest- Tammy Casey (16%), Tyler Wullenwaber (42%), and Chase Mills (42%); Approved membership interest- Tammy Casey (100%).

IT IS FURTHER ORDERED that operations authorized herein shall be subject to the terms, conditions, and limitations which have been or may hereafter be prescribed by the Commission.
