O P I N I O N A N D F I N D I N G S

On June 11, 2019, the Nebraska Public Service Commission ("Commission") entered an Order in Docket MCC-3196.01 dismissing in part and sustaining in part a complaint filed by the Motor Transportation Department ("Department") against several motor carriers for failure to comply with Neb. Rev. Stat. § 75-305.¹ The Order sustained the Department's recommendation to assess a civil penalty of five hundred dollars (\$500) and suspend the Certificate of Public Convenience and Necessity for Bus at the Yard, d/b/a Luxury Limousine ("Luxury Limousine") until Luxury Limousine came into compliance. Subsequent to the June 11, 2019 Order, Luxury Limousine satisfied its civil penalty and is in compliance with all Commission statutes and rules and regulations.

Upon due consideration, the Commission finds that the suspension of the operating authority granted to Bus at the Yard, d/b/a Luxury Limousine should be cancelled and that the Certificate of Public Convenience and Necessity should be reinstated and considered to be in good standing. The carrier is on notice that any future non-compliance may result in enforcement action, up to and including revocation of the Certificate.
