O P I N I O N A N D F I N D I N G S

By application filed June 11, 2019, Mike's Capital Cab, LLC ("Applicant"), Lincoln, seeks approval of the acquisition of the operating rights and authority granted to Servant Cab Company, LLC, d/b/a Yellow Cab Company and Capital Cab Company, Lincoln, in Certificate B-1581, which authorizes:

Transportation of passengers and their baggage by taxicab between points in Lincoln and a twenty-five (25) mile radius thereof, including, but not limited to, the communities of Crete, Firth, Garland, Greenwood, Hallam, Milford, Panama, Seward, and Wahoo, and between points in said area on the one hand, and, on the other hand, points in Nebraska over irregular routes. The transportation of passengers and their baggage originating outside of Lincoln and a twenty-five (25) mile radius thereof is not authorized, except for a continuation of a trip originating in Lincoln and a twenty-five (25) mile radius thereof, and a return to a destination in Lincoln and a twenty-five (25) mile radius thereof and shown on the same billing document as a continuation of the originating trip.

In its application, Applicant further requested that this Commission grant temporary approval to the applicant of a lease of the motor carrier properties and the certificate sought to be acquired by it. Notice of such request for temporary authority was published in The Daily Record, Omaha, Nebraska, on July 3, 2019, pursuant to the rules and regulations of this Commission.

It appears that failure to grant temporary approval may result in destruction of or injury to such motor carrier property and the certificates sought to be acquired, or interfere substantially with their future usefulness in the performance of adequate and

continuous service to the public.

Such temporary approval should be granted for ninety (90) days from the effective date of this Order pursuant to Neb. Rev. Stat. § 75-319.

O R D E R


IT IS THEREFORE ORDERED by the Nebraska Public Service Commission that the application for approval of a lease of the motor carrier properties and the certificates sought to be acquired by Mike's Capital Cab, LLC, Lincoln, should be, and it is hereby, granted to the applicant for ninety (90) days from the effective date of this Order.

IT IS FURTHER ORDERED that transportation service rendered under such temporary authority shall be subject to the provisions of Neb. Rev. Stat. § 75-311 and to the rules, regulations and requirements of the Commission; such grant of temporary authority and the operations thereunder shall not be admissible in evidence to establish or prove present or future public convenience and necessity; and no renewal or extension of the period of ninety (90) days shall be granted.



Commissioner Rhoades, dissenting:

I dissent with the majority vote to grant temporary operating authority for the transfer application. There is a pending complaint against the owner of GPS, who also owns Servant Cab Company. A second DHHS client has contacted the Commission with intention to file an additional complaint. It is unclear at this time whether the client will file a complaint against GPS or Servant Cab or both as the formal complaint has not yet been filed. However, the client has filed an informal complaint and the necessary forms for a formal complaint were mailed to the client. It is my opinion that delay of the transfer application until it is clear whether or not the formal complaint would include Servant Cab is appropriate. I therefore respectfully dissent.
