BY THE COMMISSION:

On May 23, 2019, VIP Limobus, LLC ("Applicant"), Omaha, filed an application seeking authority to amend its Certificate of Public Convenience and Necessity by removing all restrictions on its provision of open class service under Certificate B-1641. Notice of the application was published in The Daily Record, Omaha, Nebraska, on June 5, 2019. No protests were filed; therefore, Application No. 1640 was processed pursuant to Rule 002.10 of the Commission Rules of Procedure.

O P I N I O N   A N D   F I N D I N G S

Applicant is a Nebraska limited liability company with its principal office in Omaha, Nebraska. Applicant is a common carrier with authority to provide open class service using buses seating 12 passengers or more between points in Nebraska over irregular routes. Applicant's certificate also restricts the picking and and/or discharging of passengers in Douglas and Sarpy counties, other than as part of round trips which both originate and terminate outside of Douglas and Sarpy counties. Supplements 2A and 3 of Certificate B-1641 were cancelled and transferred to Certificate B-1640 on August 6, 2019.<sup>1</sup> The removal of all restrictions in the remaining portions of the certificate would authorize Applicant to provide open class

service using any vehicle type throughout the state over irregular routes. Applicant will not be authorized to provide transportation to railroad train crews or as a contractor for the Nebraska Department of Health and Human Services.

Upon due consideration, the Commission finds that the Application filed by VIP Limobus, LLC to amend its Certificate of Public Convenience and Necessity should be approved. All restrictive language contained in Certificate B-1641 should be stricken and a new Certificate should be issued authorizing the following:

CERTIFICATE AUTHORIZED

SERVICE AND TERRITORY AUTHORIZED:

Transportation of passengers and their baggage in open class service between points in Nebraska over irregular routes. RESTRICTIONS: The transportation of railroad train crews and their baggage is not authorized. HHS Designation: No.

O R D E R

IT IS THEREFORE ORDERED by the Nebraska Public Service Commission that Application No. B-1641 be, and is hereby, granted and that the Certificate of Public Convenience and Necessity granted to VIP Limobus, LLC, Omaha, be, and is hereby, amended as set forth above.
