O P I N I O N A N D F I N D I N G S

On November 14, 2018, an application was filed by Mana, Louis & Kemsean Transportation Services, LLC, d/b/a MLK Transportation Services ("Applicant"), Omaha, seeking authority as a common carrier in Nebraska intrastate commerce in the transportation of passengers by sedan and van in open class service between points in Douglas, Lancaster, and Sarpy Counties, on the one hand, and, on the other hand, points in Nebraska over irregular routes. The transportation of railroad train crews and their baggage is not authorized, and the HHS Designation is yes.

The Commission has attempted to contact Applicant by email and telephone regarding the pending application and several missing components of the application. The Application is missing the required contact information for individuals or entities that would agree to testify in support of the application, a financial statement, a HHS Designation form, a signed copy of the main application form for Applicant, and the required background check information. Applicant has not contacted the Commission to provide this information nor complied with the requirement to undergo a background check.

Based on the above, the Commission finds that a deadline for action to be taken by Applicant in this docket should be set. If the Commission does not receive any communication or direction from Applicant concerning this application by **September 11, 2019**, the Commission will dismiss the application for failure to take timely action.

O R D E R

IT IS THEREFORE ORDERED by the Nebraska Public Service Commission that a deadline for communication with the Commission by Mana, Louis & Kemsean Transportation Services, LLC, d/b/a MLK Transportation Services, Omaha, in Application B-1988 be, and is hereby, set for **September 11, 2019**.

IT IS FURTHER ORDERED that if Mana, Louis & Kemsean Transportation Services, LLC, d/b/a MLK Transportation Services, fails to take action by **September 11, 2019** in Application No. B-1988, the Commission will exercise its authority to enter an order dismissing the application
