On May 13, 2019, Recommended Care Solutions, LLC, d/b/a MedCare Mobility ("Applicant"), Omaha, filed an application for authority to establish its rates as follows:

c. Service before 7:00 a.m. or after 6:00 p.m.	\$18.66 one way

Rural Transportation	\$1.86
Additional passengers and stops	\$8.44
Wheelchair Base Rate	\$41.37

Applicant was granted authority under Application No. B-1986 as a common carrier in Nebraska intrastate commerce to transport passengers in open class service between points in Douglas, Sarpy, Washington, Dodge and Saunders counties, on the one hand, and on the other hand, points in Nebraska over irregular routes. The transportation of railroad train crews and their baggage is not authorized, and HHS designation is yes. Notice of the Application was published in The Daily Record, Omaha, on June 21, 2019. No protests were received.

Applicant is seeking to establish its initial published rate in order to provide its transportation services in eastern Nebraska. Applicant will also provide transportation services under agreements to provide non-emergency medical transportation ("NEMT") for the managed care organizations ("MCO") administering NEMT services for the Nebraska Department of Health and Human Services as of July 1, 2019. A review of Applicant's proposed rates finds that the proposed rates are reasonable.
