By application filed June 11, 2019, Mike's Transportation Services LLC ("Applicant"), Lincoln, seeks approval of the acquisition of the operating rights and authority granted to Golden Plains Services, Inc., d/b/a GPS Transportation, Lincoln, in Certificate B-1829.

Notice of the application was published in The Daily Record, Omaha, Nebraska, on July 3, 2019. No protests were filed. The Commission granted Applicant's request for temporary operating authority on July 16, 2019.¹

Applicant is owned by Mr. Mike Deal, who currently holds a common carrier Certificate of Public Convenience and Necessity under Certificate B-1901 for Mike's Handy Van, Lincoln. In addition to the above-captioned application, Mr. Deal is seeking approval of the acquisition of the operating rights and authority granted to Servant Cab Company, LLC, d/b/a Yellow Cab Company and Capital Cab Company Certificate B-1581, in Application No. B-1999. Mr. Deal was granted temporary operating authority of Servant Cab in Application No. B-1999 on July 16, 2019.²
