BY THE HEARING OFFICER:

On July 22, 2019, Oceans Enterprise, LLC, d/b/a Oceans Drive Transportation ("Applicant"), Omaha, filed an application seeking authority as a common carrier in Nebraska intrastate commerce in the transportation of passengers by van and SUV in open class service between points in Buffalo, Cass, Dodge, Douglas, Hall, Sarpy, and Washington counties. The transportation of railroad train crews and their baggage is not authorized, and the HHS designation is yes. Notice of the application was published in The Daily Record, Omaha, Nebraska, on July 30, 2019.

Timely protests were filed by Camelot Transportation, Inc. ("Camelot"); Triumph Transportation, Inc. ("Triumph"); Comstock Corporation d/b/a Action Cab; WHC NE, LLC d/b/a zTrip; WHC NE, LLC d/b/a Cornhusker Cab Company and zTrip; WHC NE, LLC d/b/a Happy Cab and zTrip; WHC NE, LLC d/b/a Checker Cab Company and zTrip; WHC NE, LLC d/b/a Yellow Cab Company and zTrip; and WHC NE, LLC d/b/a Safeway Cabs and zTrip ("zTrip") (together, "Protestants"). Protests were granted September 12, 2019.

On September 23, 2019, a planning conference was held to discuss a procedural schedule and set a hearing date. Ms. Jamie Reyes, Mr. Dillon Keiffer-Johnson, and Commissioner Mary Ridder appeared for the Commission. The following appeared via telephone: Ms. Nicole Jilek on behalf of the Applicant, and Ms. Jayden Pence on behalf the Protestants.

As a result of the planning conference, several issues were decided. Therefore, this Order serves to memorialize those decisions and provide a timeline for proceeding in this docket. I find that the following schedule should be adopted:


O R D E R
