Applicant is a certificated common carrier which holds Certificate Number B-1877. The certificate authorizes the transportation of passengers by bus in charter and special party service between all points in Nebraska over irregular routes. The transportation of railroad train crews and their baggage is not authorized, and the HHS Designation is no. The Certificate was granted on August 26, 2014. Notice of the Application was published in The Daily Record, Omaha, Nebraska, on August 16, 2019. No protests were received.

Applicant is seeking to amend its rates with the addition of new rates for weddings, holidays and other events, a decrease in the per mile charge from \$1.75 to \$1.00 per mile, and the addition of specific discounts. Upon review, the Commission finds that the proposed rates are reasonable.

Upon consideration of the application and being fully advised in the premises, the Commission is of the opinion and finds that the application should be granted.
