BY THE COMMISSION:

On September 30, 2019, Rockin' Ma & Pops DJ & Party Bus ("Applicant"), Seward, filed an application for authority to establish its rates for its use in its operations as follows:

O P I N I O N A N D F I N D I N G S

On October 1, 2019, Applicant was authorized in Application No. B-2001 to transport passengers by bus in special party and charter service between all points in Nebraska over irregular routes. The transportation of railroad train crews and their baggage is not permitted, and the HHS Designation is no.

Applicant is seeking to establish its initial published rates for use in its operations. Applicant's initial rates are to be used for any and all events that Applicant would provide its DJ and party bus services for, such as weddings, fundraisers, holiday parties, bachelor/bachelorette parties, family reunions, and other events. Upon review, the Commission finds that the proposed rates are competitive with other rates offered for similar services and are reasonable.

In applications such as these, the Commission must find that an emergency situation exists. Such a situation exists in this application, as Applicant is new to the market and has received requests to provide transportation services for upcoming events. Therefore, the Commission finds that an emergency basis exists that allows the Commission to grant the application on an emergency basis.

Upon consideration of the application and being fully advised in the premises, the Commission is of the opinion and finds that the application should be granted on an emergency basis effective October 8, 2019.
