On May, 13, 2019, Davis Entertainment LLC, d/b/a Ollie the Trolley, Omaha, filed an application seeking to extend its authority as a common carrier in Nebraska intrastate commerce to transport passengers in open class by van between points in Cass, Dodge, Douglas, Sarpy, Saunders, and Washington counties over irregular routes. The transportation of railroad train crews and their baggage is not authorized, and the designation is no. Notice of the application was published in The Daily Record, Omaha, Nebraska, on May 17, 2019.

Timely protests were filed by WHC NE, LLC d/b/a zTrip; WHC NE, LLC, d/b/a Cornhusker Cab Company; WHC NE, LLC, d/b/a Happy Cab; WHC NE, LLC, d/b/a Checker Cab Company; WHC NE, LLC, d/b/a NE, LLC, d/b/aSafeway Cabs Cab Company; WHC Yellow Inc.; Camelot Transportation, (collectively, "zTrip"); Triumph Transportation, Inc.

A hearing was scheduled for November 6, 2019. On November 2019, Applicant notified the Commission that the parties engaged in negotiations toward settlement of issues and filed a request to amend its application. On November 4, 2019, I entered an Order granting Applicant's request to amend its application. On November 4, 2019, Protestants each filed a Motion to withdraw their protests.

Based on the above, I find that the motions filed by WHC NE, LLC d/b/a zTrip; WHC NE, LLC, d/b/a Cornhusker Cab Company;
