BY THE COMMISSION:

On August 19, 2019, an application was filed by Fred's Premier Transportation Services, LLC, ("Applicant"), Omaha, seeking authority as a common carrier in Nebraska intrastate commerce in the transportation of household goods between all points in Nebraska over irregular routes. Notice of the application was published in The Daily Record, Omaha, on August 23, 2019. No protests were filed.

On September 24, 2019, Applicant was sent a letter stating that the protest period had passed and that the application would be processed pursuant to the Commission's Rules of Modified Procedure, using sworn affidavits in lieu of a hearing. Further, the letter detailed that any such affidavits must be filed with the Commission no later than 30 days from the date of the letter or the application would be dismissed. Applicant was required to return an Affidavit of Applicant and Affidavit of Supporting Shipper.

On August 19, 2019, the Commission received the Affidavit of Applicant; but, has yet to receive the required Affidavit of Supporting Shipper. Commission staff has attempted to contact Applicant by email and telephone regarding the pending application and the missing required affidavit of supporting shipper. Applicant has not contacted the Commission nor complied with the requirement to submit the affidavit.

Based on the above, the Commission finds that a deadline for action to be taken by Applicant in this docket should be set. If the Commission does not receive any communication or direction from Applicant concerning this application by **December 31, 2019**, the Commission will dismiss the application for failure to take timely action.

O R D E R

IT IS THEREFORE ORDERED by the Nebraska Public Service Commission that a deadline for communication with the Commission by Fred's Premier Transportation Services, LLC, Omaha, in Application No. M-14251, be, and is hereby, set for **December 31, 2019**.

IT IS FURTHER ORDERED that if Fred's Premier Transportation Services, LLC, fails to take action by **December 31, 2019** in Application No. M-14251, the Commission will exercise its authority to enter an order dismissing the application.
