BY THE HEARING OFFICER:

On July 22, 2019, Oceans Enterprise, LLC, d/b/a Oceans Drive Transportation ("Applicant"), Omaha, filed an application seeking authority as a common carrier in Nebraska intrastate commerce in the transportation of passengers by van and SUV in open class service between points in Buffalo, Cass, Dodge, Douglas, Hall, Sarpy, and Washington counties. The transportation of railroad train crews and their baggage is not authorized, and the HHS designation is yes. Notice of the application was published in The Daily Record, Omaha, Nebraska, on July 30, 2019.

On August 13, 2019, timely protests were filed by Camelot Transportation, Inc. ("Camelot"); Triumph Transportation, Inc. ("Triumph"); Comstock Corporation d/b/a Action Cab; WHC NE, LLC d/b/a zTrip; WHC NE, LLC d/b/a Cornhusker Cab Company and zTrip; WHC NE, LLC d/b/a Happy Cab and zTrip; WHC NE, LLC d/b/a Checker Cab Company and zTrip; WHC NE, LLC d/b/a Yellow Cab Company and zTrip; and WHC NE, LLC d/b/a Safeway Cabs and zTrip ("zTrip"). On September 12, 2019, I entered an Order granting the protests.

A hearing was scheduled for December 11, 2019. Prior to the hearing, the Commission was informed that the parties had reached a proposed settlement and that a hearing was not necessary. On December 23, 2019, Protestants each filed a Motion to withdraw their protests.

Based on the above, I find that the protests of Camelot Transportation, Inc.; Triumph Transportation, Inc.; Comstock Corporation d/b/a Action Cab; WHC NE, LLC d/b/a zTrip; WHC NE, LLC d/b/a Cornhusker Cab Company and zTrip; WHC NE, LLC d/b/a Happy Cab and zTrip; WHC NE, LLC d/b/a Checker Cab Company and zTrip;

WHC NE, LLC d/b/a Yellow Cab Company and zTrip; and WHC NE, LLC d/b/a Safeway Cabs and zTrip, should be withdrawn.

IT IS THEREFORE ORDERED by the Hearing Officer that the protests filed by Camelot Transportation, Inc.; Triumph Transportation, Inc.; Comstock Corporation d/b/a Action Cab; WHC NE, LLC d/b/a zTrip; WHC NE, LLC d/b/a Cornhusker Cab Company and zTrip; WHC NE, LLC d/b/a Happy Cab and zTrip; WHC NE, LLC d/b/a Checker Cab Company and zTrip; WHC NE, LLC d/b/a Yellow Cab Company and zTrip; and WHC NE, LLC d/b/a Safeway Cabs and zTrip be, and are hereby, withdrawn.
