On May 4, 2019, Dak Family Transportation, LLC ("Applicant"), Lincoln, Nebraska, filed an application for authority to establish its rates as follows:

<u>Description</u>	<u>Proposed</u>
Per Mile Rate	\$1.90/mi

Applicant was granted authority under Application No. B-1993 to transport passengers by van in open class between points in Douglas, Lancaster, and Sarpy Counties over irregular routes. RESTRICTIONS: Maximum of six (6) vehicles in service for Applicant's first five (5) years of operation. All trips must originate or terminate in Douglas, Lancaster, or Sarpy Counties only. No trips may originate in any Counties other than Douglas, Lancaster, or Sarpy. The transportation of railroad train crews and their baggage is not authorized. HHS designation is yes. Notice of the Application for rates was published in The Daily Record, Omaha, on November 22, 2019. No protests were received.

Applicant is seeking to establish its initial published rate in order to provide transportation services in eastern Nebraska. The proposed rate is competitive with other carriers providing similar services with similar equipment. The Commission finds that the proposed rates are reasonable.

Upon consideration of the application and being fully advised in the premises, the Commission is of the opinion and finds that the application should be granted.

IT IS THEREFORE ORDERED by the Nebraska Public Service Commission that Dak Family Transportation, LLC, Lincoln, Nebraska be, and it is hereby, authorized to establish its rates for its services effective January 12, 2020, as follows:
