BY THE COMMISSION:

On January 7, 2020, the Nebraska Public Service Commission ("Commission") entered an order opening the above-captioned docket to address those motor carriers not in compliance with the Commission's annual renewal requirements and to schedule a show cause hearing for failure to remit annual fees in accordance with Neb. Rev. Stat. § 75-305 (2018).¹

Subsequent to the Order, the following carriers remitted the required annual renewal forms, annual renewal payments, and proof of current insurance to the Commission:

Action Movers
American Eagle Van Lines, Inc.
Flat Rate Movers d/b/a Black Belt Movers, LLC
Commuter Express
Lincoln Relocation, Inc.
Ollie the Trolley
Panda Transportation
Premier Limousine, LLC
vonRentzell Van & Storage, Inc.
vonRentzell Enterprises

These carriers have complied with Neb. Rev. Stat. § 75-305 (2018) by making the requisite payments and filing the necessary documentation. As such, staff recommends the above-mentioned carriers be dismissed from the docket and excused from appearing at the show cause hearing scheduled for February 4, 2020. Furthermore, the carriers are on notice that failure to remit future annual renewal forms, fees, and

proof of insurance in a timely manner could result in administrative fines and costs.

Based on the above, the Commission finds that Accent Chauffeured Transportation; Action Movers; American Eagle Van Lines, Inc.; Flat Rate Movers d/b/a Black Belt Movers, LLC; Commuter Express; Lincoln Relocation, Inc.; Ollie the Trolley; Panda Transportation; Premier Limousine, LLC; vonRenzell Van & Storage, Inc.; and vonRenzell Enterprises should be dismissed from this docket and excused from appearing at the show cause hearing scheduled for February 4, 2020.

O R D E R

IT IS THEREFORE SO ORDERED by the Nebraska Public Service Commission that Accent Chauffeured Transportation; Action Movers; American Eagle Van Lines, Inc.; Flat Rate Movers d/b/a Black Belt Movers, LLC; Commuter Express; Lincoln Relocation, Inc.; Ollie the Trolley; Panda Transportation; Premier Limousine, LLC; vonRenzell Van & Storage, Inc.; and vonRenzell Enterprises be, and hereby is, dismissed.
