BY THE COMMISSION:

On January 7, 2020, the Nebraska Public Service Commission ("Commission") entered an order opening the above-captioned docket to address those motor carriers not in compliance with the Commission's annual renewal requirements and to schedule a show cause hearing for failure to remit annual fees in accordance with Neb. Rev. Stat. § 75-305 (2018).<sup>1</sup>

Subsequent to the Order, the following carriers remitted the required annual renewal forms, annual renewal payments, and proof of current insurance to the Commission:

A Helping Hand Moving, LLC  
Chet's Transfer, Inc.  
Fun Family Party Bus, LLC  
Mojo Mobility, LLC  
National Arbor Day Foundation  
Nebraska Party Bus  
Nebraskaland Moving & Storage  
Papio Transport Service, Inc.  
TAA, LLC

These carriers have complied with Neb. Rev. Stat. § 75-305 (2018) by making the requisite payments and filing the necessary documentation. As such, staff recommends the above-mentioned carriers be dismissed from the docket and excused from appearing at the show cause hearing scheduled for February 4, 2020. Furthermore, the carriers are on notice that failure to remit future annual renewal forms, fees, and proof of insurance in a timely manner could result in administrative fines and costs.

Additionally, Western Limousine Service, LLC, has indicated that it is no longer in business and has submitted its notification to cancel its Certificate of Public Convenience and Necessity. As this carrier is no longer in service and submitted proper notice, the Commission finds that Western Limousine Service, LLC, should be dismissed from the docket and excused from appearing at the show cause hearing scheduled for February 4, 2020.

Based on the above, the Commission finds that A Helping Hand Moving, LLC; Chet's Transfer, Inc.; Fun Family Party Bus, LLC; Mojo Mobility, LLC; National Arbor Day Foundation; Nebraska Party Bus; Nebraskaland Moving & Storage; Papio Transport Service, Inc.; TAA, LLC; and Western Limousine Service, LLC should be dismissed from this docket and excused from appearing at the show cause hearing scheduled for February 4, 2020.

O R D E R

IT IS THEREFORE SO ORDERED by the Nebraska Public Service Commission that A Helping Hand Moving, LLC; Chet's Transfer, Inc.; Fun Family Party Bus, LLC; Mojo Mobility, LLC; National Arbor Day Foundation; Nebraska Party Bus; Nebraskaland Moving & Storage; Papio Transport Service, Inc.; and TAA, LLC; and Western Limousine Service, LLC be, and hereby is, dismissed.
