On April 23, 2018, The Beautiful Life Family Home Care d/b/a Beautiful Life Medical Transport, LLC ("Applicant"), Omaha, Nebraska, filed an application for authority to establish its rates as follows:

Applicant was granted authority under Application No. B-1976 to transport passengers as a common carrier of Nebraska Intrastate Commerce in open class between points in Cass, Dodge, Douglas, Sarpy, and Washington Counties, on the one hand, and, on the other hand, points in Nebraska over irregular routes. The transportation of railroad train crews and their baggage is not authorized. HHS designation is yes. Notice of the Application for rates was published in The Daily Record, Omaha, on December 6, 2019. No protests were received.

Applicant is seeking to establish its initial published rate in order to provide transportation services in eastern Nebraska. The proposed rate is competitive with other carriers

providing similar services with similar equipment. The Commission finds that the proposed rates are reasonable.

Upon consideration of the application and being fully advised in the premises, the Commission is of the opinion and finds that the application should be granted.

IT IS THEREFORE ORDERED by the Nebraska Public Service Commission that The Beautiful Life Family Home Care d/b/a Beautiful Life Medical Transport, LLC, Omaha, be, and it is hereby, authorized to establish its rates for its services effective February 9, 2020, as follows:
