BY THE COMMISSION:

On January 7, 2020, the Nebraska Public Service Commission ("Commission") entered an order opening the above-captioned docket to address those motor carriers not in compliance with the Commission's annual renewal requirements and to schedule a show cause hearing for failure to remit annual fees in accordance with Neb. Rev. Stat. § 75-305 (2018).¹

Subsequent to the Order, the following carriers remitted the required annual renewal forms, annual renewal payments, and proof of current insurance to the Commission:

These carriers have complied with Neb. Rev. Stat. § 75-305 (2018) by making the requisite payments and filing the necessary documentation. As such, staff recommends the above-mentioned carriers be dismissed from the docket and excused from appearing at the show cause hearing scheduled for February 4, 2020. Furthermore, the carriers are on notice that failure to remit future annual renewal forms, fees, and proof of insurance in a timely manner could result in administrative fines and costs.

Additionally, Meltech, Inc. has indicated that it is no longer in business and has submitted its notification to cancel its Certificate of Public Convenience and Necessity. As this carrier is no longer in service and submitted proper notice, the Commission finds that Meltech, Inc. should be dismissed from the docket and excused from appearing at the show cause hearing scheduled for February 4, 2020.

Based on the above, the Commission finds that All About You party Bus, LLC; Budget Car and Truck Rental; Handivan Transports, Inc; Jim's Moving and Delivery Co., Inc.; Medics at Home, Inc.; Midwest Medical Transport Co., LLC; Midwest Medivan Transport Co., LLC; Murphy's Moving; Nebraska Game & Parks Commission; New World Van Lines, Inc.; Caring People Sudan; Omaha Brew Bus, LLC; Rockstar Transportation, LLC; Stutheit Transportation Serv. Inc; Travel Plus Limousines; WHC NE LLC dba Cornhusker and zTrip; WHC NE LLC dba Happy Cab and zTrip; WHC NE LLC dba Safeway Cab and zTrip; WHC NE LLC dba Yellow Cab and zTrip; WHC NE LLC dba Checker Cab and zTrip; WHC NE LLC dba Airport Transportation and zTrip; and Meltech, Inc. should be dismissed from this docket and excused from appearing at the show cause hearing scheduled for February 4, 2020.


