BY THE HEARING OFFICER:

On September 13, 2019, Thomas Transportation ("Applicant"), Omaha, filed an application seeking authority as a common carrier in Nebraska intrastate commerce in the transportation of passengers in open class service between all points in Nebraska over irregular routes. The transportation of railroad train crews and their baggage is not authorized, and HHS Designation is no. Notice of the Application was published in The Daily Record, Omaha, Nebraska, on October 17, 2019.

On November 1, 2019, timely protests were filed by Camelot Transportation, Inc. and Triumph Transportation, Inc. On November 5, 2019, timely protests were filed by WHC NE, LLC d/b/a zTrip; WHC NE, LLC d/b/a Cornhusker Cab Company and zTrip; WHC NE, LLC d/b/a Happy and zTrip; WHC NE, LLC d/b/a Checker Cab Company and zTrip; WHC NE, LLC d/b/a Yellow Cab Company and zTrip; and WHC NE, LLC d/b/a Safeway Cabs and zTrip. Protests were granted on November 26, 2019.

A hearing was scheduled for March 4, 2020. On January 28, 2020, I entered a Hearing Officer's Order granting Applicant's request to amend its Application. On February 5, 2020, Protestants filed Motions for Leave to Withdraw Protest and Withdrawal of Protests based upon Applicant's amendment request.

Based on the above, I find that the Motions for Leave to Withdraw Protest and Withdrawal of Protests filed by Camelot Transportation, Inc.; Triumph Transportation, Inc.; WHC NE, LLC d/b/a zTrip; WHC NE, LLC d/b/a Cornhusker Cab Company and zTrip; WHC Ne, LLC d/b/a Happy Cab and zTrip; WHC NE, LLC d/b/a Checker Cab Company and zTrip; WHC NE, LLC d/b/a Yellow Cab Company and

zTrip; and WHC NE, LLC d/b/a Safeway Cabs and zTrip, should be granted and said Protestants protest be considered withdrawn.
