Rev. Stat. §§ 75-305 (fees), 75-307 (insurance), and 75-308 (rates) (Reissue 2018), and with the rules and regulations of the Commission; and if upon expiration of such time, Applicant has not complied with such terms and conditions, this Order shall, after reasonable notice to Applicant, be of no further force and effect.

IT IS FURTHER ORDERED that Applicant shall not conduct operations until a Certificate of Public Convenience and Necessity is issued.

IT IS FINALLY ORDERED the Certificate of Public Convenience and Necessity authorized shall be subject to the terms, conditions, and limitations which have been, or may hereafter be, prescribed by the Commission.
