OPINION AND FINDINGS

On March 3, 2020, Applicant was authorized in Application No. B-2007 to transport passengers in special party service between points in Lincoln County over irregular routes. The transportation of railroad train crews and their baggage is not permitted, and the HHS Designation is no.

Applicant is seeking to establish its initial published rates for use in its operations. The proposed rate is competitive with other carriers providing similar services with similar equipment. Upon review, the Commission finds that the proposed rate is reasonable.

In applications such as these, the Commission must find that an emergency situation exists. Such a situation exists in this

application, as Applicant is new to the market and has received requests to provide transportation services. Therefore, the Commission finds that an emergency basis exists that allows the Commission to grant the application on an emergency basis.

Upon consideration of the application and being fully advised in the premises, the Commission is of the opinion and finds that the application should be granted on an emergency basis effective March 10, 2020.

ORDER

IT IS THEREFORE ORDERED by the Nebraska Public Service Commission that N.H.A.A.D. d/b/a The Party Bus, North Platte, Nebraska, be, and it is hereby, authorized to establish its rates for its services on an emergency basis effective March 10, 2020 as follows:
