By application filed October 22, 2019, My Princess' Limo Services, LLC ("Applicant"), Madison, Nebraska, seeks authority to operate as a common carrier as follows:

AUTHORITY SOUGHT

Transportation of passengers by luxury or stretch limousine in limousine service between points in Madison County and communities within a 60-mile radius of Madison County over irregular routes. RESTRICTIONS: The transportation of railroad train crews and their baggage is not authorized. HHS Designation: No.

Notice of the application was published in The Daily Record, Omaha, Nebraska, on November 11, 2019. Because no protests were filed, Application No. B-2006 was processed pursuant to the Commission's Rule of Modified Procedure.

IT IS FURTHER ORDERED that applicant shall not be issued the Certificate of Public Convenience and Necessity authorized by the Commission unless and until Applicant has fully complied, within a reasonable time from the effective date of this Order, with Neb. Rev. Stat. §§ 75-305 (fees), 75-307 (insurance), and 75-308 (rates), and with the rules and regulations of the Commission, and if upon expiration of such terms and conditions, this Order shall, after reasonable notice to Applicant, be of no further force and effect.

IT IS FINALLY ORDERED that Applicant shall not conduct operations until a Certificate of Public Convenience and Necessity is issued.
