OPINIONS AND FINDINGS

By application filed with the Commission on April 3, 2020, Ronald D. Allgood d/b/a Tree City Cab Company ("Applicant"), Nebraska City, Nebraska, requests a suspension of the Certificate of Public Convenience and Necessity issued in Application B-1320 until September 1, 2020. Applicant is authorized to provide, with restrictions, transportation by taxicab between points in Otoe County on the one hand and points in Nebraska on the other, in addition to points between Otoe and Nemaha Counties over irregular routes using vans with a rated capacity of 12 passengers or less.

On March 31, 2020, the Nebraska Department of Health and Human Services ("HHS") issued Directed Health Measure Order 2020-007 in order to reduce morbidity and mortality; minimize disease transmission; protect health care personnel and preserve health care system functionality due to the COVID-19 global pandemic. Applicant states that the majority of its transportation services are provided for HHS Adult Family Services and Child Protective Services, which have been suspended. As a result, Applicant is no longer in a position to provide its usual taxicab services requests that its Certificate be suspended.

Upon due consideration of this request, the Commission is of the opinion and finds that the request should be granted and the Certificate of Public Convenience and Necessity in Application B-1320 should be suspended until September 1, 2020.

ORDER

IT IS THEREFORE ORDERED by the Nebraska Public Service Commission that the request of Ronald D. Allgood d/b/a Tree City Cab Company, Nebraska City, Nebraska, to suspend the Certificate
