Notice of the Application for rates was published in $\underline{\text{The Daily}}$ $\underline{\text{Record}}$, Omaha, on March 23, 2020. No protests were received.

OPINION AND FINDINGS

Applicant was granted common carrier authority under Application No. B-1996 to transport passengers in open class service between points in Douglas and Sarpy counties over irregular routes. The transportation of railroad train crews and their baggage is not authorized, and HHS Designation is No. Applicant is seeking to establish its initial published rates for use in its new services. A review of Applicant's proposed rates in comparison to rates offered by similar carriers for similar services finds that the proposed rates are reasonable.
