BY THE HEARING OFFICER:

On May 21, 2019, Richwood Transport of Nebraska, LLC ("Applicant"), Middleton, Wisconsin, filed an application seeking authority as a contract carrier in Nebraska intrastate commerce in the transportation of passengers by van in open class service between points in Douglas, Lancaster, Sarpy, Hall, Platte, Gage, Dodge, Madison, Lincoln, and Scotts Bluff counties over irregular routes pursuant to a contract with the Nebraska Department of Health and Human Services, a Medicaid-managed care organization under contract with NDHHS, or another agent working on behalf of NDHHS. The transportation of railroad train crews and their baggage is not authorized, and HHS Designation is yes. Notice of the Application was published in The Daily Record, Omaha, Nebraska, on July 1, 2019.

Timely protests were filed by Camelot Transportation, Inc.; Triumph Transportation, Inc.; Comstock Corporation d/b/a Action Cab; WHC NE, LLC d/b/a zTrip; WHC NE, LLC d/b/a Cornhusker Cab Company and zTrip; WHC NE, LLC d/b/a Happy Cab and zTrip; WHC NE, LLC d/b/a Checker Cab Company and zTrip; WHC NE, LLC d/b/a Yellow Cab Company and zTrip; and WHC NE, LLC d/b/a Safeway Cabs and zTrip.

A telephonic planning conference in the above-captioned matter was held on April 23, 2020. On May 7, 2020, I entered an Order adopting the procedural schedule agreed to at this planning conference. On May 7, 2020, Applicant filed a written request to set aside the current procedural schedule and to postpone the hearing in this matter. Applicant recently retained counsel and to ensure due process and fair representation in this matter has made this request.

Having been duly advised, I hereby find that the hearing scheduled in this matter for June 16, 2020 shall be rescheduled to a date to be later determined. In addition, I find that a planning conference should also be scheduled in order to develop an updated procedural schedule to use going forward in this matter.

O R D E R

IT IS THEREFORE ORDERED by the Hearing Officer that the hearing scheduled for June 16, 2020 be, and is hereby, postponed.

IT IS FURTHER ORDERED that a planning conference shall be scheduled to lay out an updated procedural schedule to utilize moving forward.


