BY THE COMMISSION:

On September 10, 2018 NOVA Medical Trans, LLC ("Applicant"), Lincoln, filed an application seeking authority as a common carrier to transport passengers in open class by van in between points in Douglas and Lancaster counties, and points between said counties, over irregular routes. The transportation of railroad train crews and their baggage is not authorized, and the HHS designation is yes. Notice of the application was published in The Daily Record, Omaha, Nebraska, on October 16, 2018. Timely protests were filed by Camelot Transportation, Triumph Transportation, and Golden Plains Services Inc. d/b/a GPS Transportation. Protests were granted on April 3, 2019.

On April 29, 2019, the Hearing Officer entered an Order adopting the procedural schedule and scheduling a hearing for July 24, 2019. On July 5, 2019, the Commission was informed that Applicant's counsel withdrew his representation. A conference call was held on July 10, 2019, wherein Applicant requested the hearing set for July 24, 2019 be continued to allow for time to retain counsel. There were no objections to Applicant's request.

On February 18, 2020, Commission staff sent a letter to Applicant requiring Applicant to contact the Commission by February 28, 2020 regarding Applicant's intent to proceed with

their application. No such contact was made. On March 24, 2020, the Commission entered an Order of Pending Dismissal, requiring the Applicant to contact the Commission about its application no later than April 17, 2020. To date, Applicant has not submitted a withdrawal request or taken any further action on the application.

Based on the above, the Commission finds that Application No. B-1982 for NOVA Medical Trans, LLC, Lincoln, should be dismissed.

ORDER

IT IS THEREFORE ORDERED by the Nebraska Public Service Commission that Application B-1982 be, and is hereby, dismissed.
