## O P I N I O N     A N D     F I N D I N G S

On October 4, 2019, LaToya Prince Ventures, LLC ("Applicant"), Omaha, filed an application seeking authority as a contract carrier in Nebraska intrastate commerce in the transportation of passengers in open class service between all points in Nebraska over irregular routes pursuant to a contract with the Nebraska Department of Health and Human Services. The transportation of railroad train crews and their baggage is not authorized, and the HHS designation is yes. Notice of the application was published in The Daily Record, Omaha, Nebraska, on March 19, 2020.
