OPINION AND FINDINGS

On April 13, 2020, Fremont Cab Service, LLC ("Applicant"), Fremont, Nebraska, filed an application for authority to amend its rates. Notice of the application was published in The Daily Record, Omaha, Nebraska on May 8, 2020. Because no protests were filed, Application TR-217/B-1702 was processed pursuant to the Commission's Rule of Modified Procedure.

On May 5, 2020, the Commission entered an order denying Applicant's request to amends its rates on an emergency basis. In that order, the Commission noted that in its June 30, 2009 order granting Applicant's last rate increase, the Commission advised Applicant to make more timely applications to ensure smaller rate increases for the general public. Due to the length of time since Applicant's last rate increase and the substantiality in which Applicant seeks to increase its current rates, more information is needed before entry of a final order.

At this time, I find the hearing should be held on July 14, 2020 at 11:00 a.m. This hearing will be held electronically via Webex. As the meeting will be held electronically, and no quorum of the public body will be physically present together, there will be no public in-person attendance.
