OPINION AND FINDINGS

On May 27, 2020, My Princess' Limo Services, LLC ("Applicant"), Madison, Nebraska, filed an application for authority to establish its rates as follows:

Deposit	\$200.00
Holidays (per hour)	\$350.00
Promotions & Discounts (limited)	10% - 40% family, friends, military, and religious events

Any miles gone over that is under an hour \$5.00/mile

If appointment is not cancelled 2 weeks ahead of time the deposit will not be refunded.

If vehicle is left dirty a fee of \$50.00 will be deducted from deposit.

Deposit will not be refunded if any damages are done to the vehicle. Will charge according to damage.

Emergency action was requested.

Applicant was granted authority under Application No. B-2006 to transport passengers as a common carrier of Nebraska intrastate commerce by luxury or stretch limousine in limousine service between points in Madison County and communities within a 60-mile radius of Madison County over irregular routes. The transportation of railroad train crews and their baggage is not authorized. HHS designation is no. Although the application requested emergency action, notice of the Application was published in The Daily Record, Omaha, on June 4, 2020. No protests were received.

Applicant is seeking to establish its initial published rate in order to provide transportation services via limousine in Madison County and the surrounding communities. A review of Applicant's proposed rates finds that the proposed rates are reasonable, with one exception. The rates include a special discounted rate range for family, friends, military, religious events, which represents a decrease from the general rate anywhere from 10 percent to 40 percent. foremost, Neb. Rev. Stat. § 75-126(2) allows a common carrier to perform services for free or reduced rates for certain customers, none of the individuals who would qualify for Applicant's discounts fall under any of the enumerated exceptions to the general rule. Moreover, Applicant provided a range of different discounts and not specific discounts for each category. Even if these proposed discounts did not violate Neb. Rev. Stat. § 75-126(2), such discounts are too subjective to determine how the rate would be applied. For the foregoing reasons, the Commission will not approve such rates.

Upon consideration of the application and being fully advised in the premises, the Commission is of the opinion and finds that the application should be granted, in part. Since Applicant requested emergency implementation of its proposed rates, the rates should be considered effective as of the date of this Order.

ORDER

IT IS THEREFORE ORDERED by the Nebraska Public Service Commission that My Princess' Limo Services, LLC, Madison,
