BY THE COMMISSION:

By Application filed June 16, 2020, Oceans Enterprise, LLC, d/b/a Oceans Drive Transportation ("Applicant"), Omaha, seeks to extend its existing authority. Notice of the Application was published in The Daily Record, Omaha, Nebraska, on June 18, 2020. No protests were filed; therefore, the Application was processed pursuant to the Commission's Rule of Modified Procedure.

O P I N I O N A N D F I N D I N G S

Applicant currently provides transportation to passengers by van and SUV in open class service between points in Buffalo, Cass, Dodge, Washington, Douglas, Hall, and Sarpy counties with the following restrictions: maximum of ten (10) total vehicles in service and/or operation at any given point in Cass, Dodge, Washington, Douglas and Sarpy counties; service by van and SUV only; all trips originating or terminating in Cass, Dodge; Washington, Douglas and Sarpy counties must be completed within a 100-mile radius of the point of origination. The transportation of railroad train crews is not authorized, and HHS Designation is yes. The proposed application would authorize Applicant to provide transportation of passengers statewide. HHS Designation is yes. The application did not seek to remove any current restrictions. Applicant states that it has increased the number of vehicles in its fleet in order to accommodate the proposed service area.

After due consideration and being fully advised in the premises, the Commission is of the opinion and finds:

1. Applicant is able properly to conform to applicable provisions of Neb. Rev. Stat. §§ 75-301 to 75-322, and the requirements, rules and regulations of the Commission thereunder.
2. Upon compliance with Neb. Rev. Stat. §§ 75-305 (fees), 75-307 (insurance), and 75-308 (rates), and with the rules and regulations of the Commission, a Certificate of Public Convenience and Necessity should be issued as follows:

CERTIFICATE AUTHORIZED

SERVICE AND TERRITORY AUTHORIZED:

COMMON: transportation of passengers and their baggage by van in open class service between all points in Nebraska over irregular routes.

RESTRICTIONS: Maximum of ten (10) total vehicles in service and/or operation at any given point in Cass, Dodge, Washington, Douglas and Sarpy counties. Service by van and SUV only. All trips originating or terminating in Cass, Dodge; Washington, Douglas and Sarpy counties must be completed within a 100-mile radius of the point of origination. The transportation of railroad train crews is not authorized. HHS Designation is yes.

3. The Application for extended authority should be granted.

O R D E R

IT IS THEREFORE ORDERED by the Nebraska Public Service Commission that Application No. B-2002, Supplement 1 be, and it is hereby, granted; and that upon compliance with the terms and conditions set forth in this Order, a Certificate of Public Convenience and Necessity shall be issued to Oceans Enterprise, LLC, d/b/a Oceans Drive Transportation, Omaha, Nebraska, in Application No. B-2002, Supplement 1, authorizing the operations set forth in the foregoing findings.

IT IS FURTHER ORDERED that Applicant shall not be issued the Certificate of Public Convenience and Necessity authorized by the Commission unless and until Applicant has fully complied within a reasonable time from the effective date of this Order

with Neb. Rev. Stat. §§ 75-305 (fees), 75-307 (insurance), and 75-308 (rates), and with the rules and regulations of the Commission; and if upon expiration of such time Applicant has not complied with such terms and conditions, this Order shall, after reasonable notice to Applicant, be of no further force and effect.





IT IS FURTHER ORDERED that Applicant shall not conduct the operations until a Certificate of Public Convenience and Necessity is issued.

IT IS FURTHER ORDERED that the Certificate of Public Convenience and Necessity authorized shall be subject to the terms, conditions and limitations which have been, or may hereafter be, prescribed by the Commission.
