O P I N I O N A N D F I N D I N G S

The Nebraska Public Service Commission ("Commission"), on its own motion, is seeking revocation of the Certificate of Public Convenience and Necessity issued to Good Times Limousine, Inc., Omaha, in Certificate No. B-1944.

The Commission granted Good Times Limousine authority to operate as a common carrier transporting passengers by bus between all points in Nebraska over irregular routes. The authority was granted on January 1, 2017.

Neb. Rev. Stat. § 75-305 requires all regulated motor carriers to pay an annual fee not exceeding eighty dollars (\$80) for each motor vehicle operated. Annual fees are due and payable to the Commission on or before January 1 and delinquent March 1.¹

Good Times Limousine failed to pay its annual renewal fee as required by § 75-305 and was therefore named a Respondent in a Department Complaint opened March 10, 2020.² Hearing on the Complaint was held on May 5, 2020. No representative of Good

Times Limousine appeared at the hearing. Department staff recommended that the Certificate of Public Convenience and Necessity held by Good Times Limousine be revoked and the carrier assessed a civil penalty of three-thousand, eight-hundred dollars (\$3,800). The Commission entered an Order on August 25, 2020 sustaining the complaint against Good Times Limousine and adopting Department recommendations.³

Based on the above, the Commission is of the opinion and finds that the authority granted to Good Times Limousine, Inc., Omaha, in Certificate B-1944 should be revoked for failure to comply with Neb. Rev. Stat. § 75-305. All vehicle plates assigned by the Commission to Good Times Limousine must be returned to the Commission within ten (10) days of the effective date of this Order. No subsequent applications for authority will be satisfied until the above-mentioned civil penalty is satisfied.

O R D E R

IT IS THEREFORE ORDERED by the Nebraska Public Service Commission that the Certificate of Public Convenience and Necessity issued to Good Times Limousine, Inc., Omaha, in Certificate B-1944 be, and is hereby, revoked.

IT IS FURTHER ORDERED that all vehicle plates assigned by the Commission must be returned to the Commission within ten (10) days of the effective date of this Order.
