On July 15, 2019, Premier Limousine ("Applicant"), Kearney, Nebraska, filed an application for authority to establish its rates for its use in its operations as follows:

No. B-1922. Applicant will provide for the transportation of passengers by luxury or stretch limousine and sedan in Custer, Lincoln, Dawson, Buffalo, Sherman, Valley, Garfield, Loup, Blaine, Thomas, Logan and Holt counties, on the one hand, and, on the other hand, points in Nebraska over irregular routes. The transportation of railroad train crews and their baggage is not authorized and HHS Designation is no.

Applicant's proposed rate application seeks to establish rates to be used in its new operations. The Commission finds that the proposed rates are reasonable.

Upon consideration of the Application and being fully advised in the premises, the Commission is of the opinion and finds that the Application should be granted and rates be effective September 6, 2020.

O R D E R

IT IS THEREFORE ORDERED by the Nebraska Public Service Commission that Premier Limousine, Kearney, be, and it is hereby, authorized to establish its rates for its services effective September 6, 2020, as follows:
