BY THE COMMISSION:

On August 25, 2020, the Nebraska Public Service Commission ("Commission") entered an Order granting the rate application of Beautiful Life Family Home Care d/b/a Beautiful Life Medical Transport, LLC ("Applicant"), Omaha. Subsequent to the entry of the Order, the Commission was notified that language describing the per mile rate for Ambulatory and Wheelchair trips over 5 miles incorrectly described these rates as "after the first 8 miles."

O P I N I O N A N D F I N D I N G S

The purpose of an order Nunc Pro Tunc is to correct the record which has been made so that it will truly reflect the action taken which, through inadvertence or mistake, was not truly recorded.¹ Clerical errors may be corrected by an order Nunc Pro Tunc, but not judicial errors.²

Based on the above, the Commission finds that an order Nunc Pro Tunc should be entered. The rates listed on page three of the August 25, 2020 Commission Order granting Applicant's rates in Application No. BR-587/B-1976 should be amended as follows:
