O P I N I O N A N D F I N D I N G S

On March 23, 2020, the Nebraska Public Service Commission ("Commission") received a Form K Insurance Cancellation Notice for Bus at the Yard, LLC, d/b/a Luxury Limousine ("Luxury Limousine"), Lincoln, who holds a Certificate of Public Convenience and Necessity under Certificate No. B-1909. The Form K received from Columbia Insurance Company had a cancellation date of April 23, 2020.

Pursuant to Commission Rule 006, all carriers are required to file documents with the Commission that show proof of current insurance that meets the minimum insurance requirements. Luxury Limousine was notified by letter of the cancellation notice but did not respond to the letter or any department outreach. However, representatives of Luxury Limousine have only recently contacted the Commission to discuss compliance. To date, the Commission has not received a current Form E Insurance filing and the department has notified the carrier to cease and desist any operations. Taking into account the totality of past and present compliance issues, the Commission has concerns with the carrier's fitness to provide safe and reliable transportation services pursuant to its authority.

After due consideration of the circumstances, the Commission finds that Bus at the Yard, LLC, d/b/a Luxury Limousine, Lincoln, should be ordered to show cause as to why its Certificate of Public Convenience and Necessity should not be suspended, modified, or revoked in whole or in part, or why administrative fines not be assessed for failure to maintain required liability insurance and provide proof of such insurance to the Commission in accordance with Commission Rule 006. Therefore, hearing on this matter shall be held on **Tuesday,**
