## BY THE HEARING OFFICER:

On September 30, 2020, an entry of appearance on behalf of LaToya Prince Ventures, LLC ("Applicant") was filed by Ms. Lindsey Schuler with Croker, Huck, Kasher, DeWitt, Anderson & Gonderinger, LLC. The entry of appearance was accompanied by a Motion for Extension of Time to Respond to Discovery Requests. Prior to the appearance of counsel, Applicant agreed to respond by September 30, 2020 to discovery requests filed by Camelot Transportation, Inc.; Triumph Transportation, Inc.; WHC NE, LLC d/b/a Cornhusker Cab Company and zTrip; WHC NE, LLC d/b/a Happy Cab and zTrip; WHC NE, LLC d/b/a Yellow Cab Company and zTrip; WHC NE, LLC d/b/a Safeway Cabs and zTrip; and Comstock Corporation d/b/a Action Cab (together, "Protestants") during a September 8, 2020 telephonic hearing on Protestants' Motion to Compel Discovery.

In its Motion, Applicant stated that counsel had recently been retained and that further time is needed to respond to Protestant's discovery requests.

Upon due consideration and being advised on the premises, I find that Applicant's Motion for an extension of time to Protestants' discovery requests should be granted. Given the circumstances, I believe an extension of twenty-seven (27) days is warranted. Therefore, I find that Applicant has until Monday, October 26, 2020 to respond to Protestant's discovery requests.

## ORDER

IT IS THEREFORE ORDERED by the Hearing Officer that the motion by LaToya Prince Ventures, LLC, for an extension of time to respond to Protestant's discovery requests be, and is hereby, granted and the deadline for responding to Protestant's discovery request is extended to Monday, October 26, 2020.
