BY THE COMMISSION:

On or about February 27, 2020, an application was filed by Yellow Cab Beatrice ("Applicant"), Beatrice, seeking a name change to Yellow Cab Beatrice d/b/a Leisure Taxi. Notice of the application was published in The Daily Record, Omaha, Nebraska, on July 20, 2020. No protests were filed; therefore, the application was processed pursuant to the Commission's Rule of Modified Procedure.

OPINION AND FINDINGS

Applicant is a Nebraska Corporation with its principal place of business in Beatrice, Nebraska. Applicant operates as a common carrier with a Certificate of Public Convenience and Necessity under Certificate No. B-1874. On December 3, 2020, the Commission granted Applicant's acquisition of the authority granted to Leisure Taxi, LLC, Lincoln. Applicant now seeks an Order from the Commission approving a name change to Yellow Cab Beatrice d/b/a Leisure Taxi.

Upon consideration of Applicant's filing and the files and records of the Commission relative to Applicant and being fully advised in the premises, the Commission is of the opinion and finds:

1. Applicant has changed its name, but no other aspect of the organization of Applicant has changed.
2. The authority held by Applicant should be carried in the files of the Commission in the new name of the Applicant to wit: Yellow Cab Beatrice d/b/a Leisure Taxi.
3. No further action or relief should be granted pursuant to Applicant's notification and request for official recognition of its new name.
