## OPINION AND FINDINGS

The Nebraska Public Service Commission ("Commission"), on its own motion, is seeking to require Denver Coach, Inc. ("Denver Coach"), to show cause as to why the Certificate of Public Convenience and Necessity granted to Denver Coach, Scottsbluff, in Certificate B-1343, should not be revoked.

Neb. Rev. Stat. § 75-305(1) requires all regulated motor carriers to pay an annual fee not exceeding eighty dollars (\$80) for each motor vehicle operated. Annual fees are due and payable to the Commission on or before January 1 and are delinquent March 1.¹ Denver Coach failed to pay its annual renewal fee as required by § 75-305(1) and was therefore named a Respondent in a Departmental Complaint opened on March 10, 2020. ²

On April 29, 2020, Wally Schlager, owner of Denver Coach, was personally served a copy of the Complaint and all related Orders by the Scotts Bluff County Sheriff's Office. Prior to the hearing, Commission staff spoke with Mr. Schlager, who indicated the annual renewal would be paid. Hearing on the Complaint was held May 5, 2020. Denver Coach did not appear at the hearing.

On June 30, 2020, the Commission entered an Order sustaining the Complaint and ordered Denver Coach to complete all outstanding compliance within fifteen (15) days after the effective date of the Order or be subject to further Commission action.<sup>3</sup> The Order stated that additional action could include assessment of a three-thousand, eight-hundred dollar (\$3,800) fine as calculated by the transportation department's annual renewal fining policy.<sup>4</sup>

To date, Denver Coach has not taken action to resolve the Complaint or pay the annual fee. Denver Coach has also been unresponsive to the Department's subsequent communication attempts.

due consideration of the circumstances, the Commission finds that Denver Coach, Inc., Scottsbluff, should be ordered to show cause as to why its Certificate of Public Convenience and Necessity should not be revoked for failure timely remit annual renewal fees in accordance with Neb. Rev. Stat. § 75-305(1). Therefore, hearing on this matter shall be held on Monday, November 16, 2020 at 1:30 p.m. in the Commission Hearing Room, 1200 N Street, Suite 300, Lincoln, Nebraska. comply with Directed Health Measures, seating will be limited for public in-person attendance. ### ORDER

IT IS THEREFORE ORDERED by the Nebraska Public Service Commission that Denver Coach, Inc., Scottsbluff, be, and is hereby, ordered to show cause as to why its Certificate of
