#### OPINION AND FINDINGS

The Nebraska Public Service Commission ("Commission"), on its own motion, is seeking to require Big O's Party Bus, LLC ("Big O's"), to show cause as to why the Certificate of Public Convenience and Necessity granted to Big O's, Columbus, in Certificate B-1794, should not be revoked.

Neb. Rev. Stat. § 75-305(1) requires all regulated motor carriers to pay an annual fee not exceeding eighty dollars (\$80) for each motor vehicle operated. Annual fees are due and payable to the Commission on or before January 1 and are delinquent March  $1.^1$  Big O's failed to pay its annual renewal fee as required by § 75-305(1) and was therefore named a Respondent in a Departmental Complaint opened on March 10, 2020.  $^2$ 

Hearing on the Complaint was held May 5, 2020. Mr. Todd Oborny made a statement on behalf of Big O's, detailing the efforts made by Big O's to pay its annual renewal.<sup>3</sup> Prior to and after the hearing, department staff spoke with Mr. Oborny

regarding the steps Big O's must take to come back into compliance with the Commission.

On June 30, 2020, the Commission found that Big O's should pay a civil penalty of one-thousand seven-hundred dollars (\$1,700), but allowed payment of the fine in partial amounts over time. Further, the Commission stated that failure to pay the penalty within thirty (30) days from the mailing of the Order may result in the matter being referred to the Nebraska Attorney General's Office for collection through the District Court of Lancaster County and further Commission action. A stipulated agreement was sent to Big O's via certified mail but was returned as undeliverable. To date, no action has been taken by Big O's to resolve the Complaint or respond to the Department's subsequent communication attempts.

consideration of the circumstances, due Commission finds that Big O's Party Bus, LLC, Columbus, should be ordered to show cause as to why its Certificate of Public Convenience and Necessity should not be revoked for failure timely remit annual renewal fees in accordance with Neb. Rev. Stat. § 75-305(1). Therefore, hearing on this matter shall be held on Monday, November 16, 2020 at 1:30 p.m. in the Commission Hearing Room, 1200 N Street, Suite 300, Lincoln, Nebraska. comply with Directed Health Measures, seating will be limited for public in-person attendance.
