OPINION AND FINDINGS

The Nebraska Public Service Commission ("Commission"), on its own motion, is seeking to require Nebraska Taxi, LLC ("Nebraska Taxi"), to show cause as to why the Certificate of Public Convenience and Necessity granted to Nebraska Taxi, Lexington, in Certificate B-1880, should not be revoked.

Neb. Rev. Stat. § 75-305(1) requires all regulated motor carriers to pay an annual fee not exceeding eighty dollars (\$80) for each motor vehicle operated. Annual fees are due and payable to the Commission on or before January 1 and are delinquent March 1.¹ Nebraska Taxi failed to pay its annual renewal fee as required by § 75-305(1) and was therefore named a Respondent in a Departmental Complaint opened on March 10, 2020. ²

On April 17, 2020, a copy of the Complaint and all related orders were delivered via priority mail to Nebraska Taxi. Commission staff spoke with a company representative, who indicated the annual renewal would be paid. Hearing on the Complaint was held May 5, 2020. However, no representative of Nebraska Taxi appeared at the hearing. The Commission found that

the Complaint against Nebraska Taxi be sustained, and that Nebraska Taxi should pay its annual fees and be assessed a civil penalty of three-thousand, eight-hundred dollars (\$3,800) as calculated by the transportation department annual renewal fining policy.³

To date, Nebraska Taxi has taken no action to resolve the Complaint or pay the annual fee. Nebraska Taxi has also not responded to the Department's subsequent communication attempts.

consideration of the due circumstances, the Commission finds Nebraska Taxi, LLC, Lexington, should be ordered to show cause as to why its Certificate of Public Convenience and Necessity should not be revoked for failure timely remit annual renewal fees in accordance with Neb. Rev. Stat. § 75-305(1). Therefore, hearing on this matter shall be held on Monday, November 16, 2020 at 1:30 p.m. in the Commission Hearing Room, 1200 N Street, Suite 300, Lincoln, Nebraska. comply with Directed Health Measures, seating will be limited for public in-person attendance. IT IS THEREFORE ORDERED by the Nebraska Public Service Commission that Nebraska Taxi, LLC, Lexington, be, and is hereby, ordered to show cause as to why its Certificate of Public Convenience and Necessity should not be revoked for failure to timely remit annual fees in accordance § 75-305(1).

IT IS FURTHER ORDERED that hearing on this matter shall be scheduled for Monday, $November\ 16$, $2020\ at\ 1:30\ p.m.$ as provided herein.
