OPINION AND FINDINGS

Applicant is a Nebraska Limited Liability Company with its principal business address in Omaha, Nebraska. Applicant was granted authority under Application No. B-2018 to transport passengers as a common carrier by sedan and van between points

in Douglas, Dodge, Sarpy, Washington, and Cass counties, over irregular routes. The transportation of railroad train crews and their baggage is not authorized. HHS designation is yes.

Applicant is seeking to establish its initial published rates for use in its operations. A review of Applicant's proposed rates in comparison to rates offered by similar carriers for similar services finds that the proposed rates are reasonable.

Upon consideration of the application and being fully advised in the premises, the Commission is of the opinion and finds that the application should be granted.

ORDER

IT IS THEREFORE ORDERED by the Nebraska Public Service Commission that Compassion Care Senior Services, LLC d/b/a Compassion Care Medical Transport, Omaha, Nebraska, be, and it is hereby, authorized to establish its rates for its services effective December 13, 2020, as follows:
