On November 3, 2020, TAA, LLC d/b/a BIG Premier Limousine ("Applicant"), Grand Island, Nebraska, filed an application for authority to establish its rates for its use in its operations as follows:

O P I N I O N A N D F I N D I N G S

On January 27, 2020, Applicant filed an application to acquire the operating rights and authority granted to TAA, LLC d/b/a BIG Premier Limousine, Grand Island, in Certificate B-1806. On July 14, 2020, the Commission granted the acquisition and cancelled Certificate No. B-1806.¹

Applicant is a Nebraska Limited Liability Company with its principal business address in Grand Island, Nebraska. Applicant was granted authority under Application No. B-2014 to transport passengers and their baggage by limousine service between points in Sherman, Buffalo, Custer, Garfield, Hall, Howard, Loup, Blaine, Valley, Greeley, Hamilton, Kearney, Phelps, Adams, Webster, Clay, Chase, Dundy, Hayes, Hitchcock, Frontier, Red Willow, Furnas, Gosper, Dawson, Harlan, Franklin, Nuckolls, Boone, Nance, and Merrick counties and between points in Nebraska over irregular routes. The transportation in sedan, van, and SUV style limousine vehicles is authorized. The transportation of railroad train crews and their baggage is not authorized. HHS designation is no. Applicant was also granted authority to transport passengers by bus in charter and special party between points in Nebraska over irregular routes. The transportation of railroad train crews and their baggage is not authorized. HHS designation is no.

Applicant seeks to establish rates for use in its new operations. The proposed rates represent an increase to those previously approved and used under the previous ownership but are structured in a similar manner. The rates include a fee structured on an hourly basis for both Applicant's limousine and bus service. The proposed rates are comparable to other rates utilized by other carriers for similar services. The Commission find that the proposed rates are reasonable.

Upon consideration of the application and being fully advised in the premises, the Commission is of the opinion and finds that the application should be granted.

O R D E R

IT IS THEREFORE ORDERED by the Nebraska Public Service Commission that TAA, LLC d/b/a BIG Premier Limousine, Grand Island, Nebraska, be, and it is hereby, authorized to amend its rates for its services effective December 20, 2020, as follows:
