Notice of the Application was published in The Daily Record, Omaha, Nebraska, on September 22, 2020.

Timely protests were filed by Camelot Transportation, Inc.("Camelot") and Triumph Transportation, Inc.("Triumph"). Protests were granted November 5, 2020.
